

POUR THINGS COFFEE RENTAL TERMS AND CONDITIONS

Please read the following terms and conditions carefully before proceeding with the rental of our coffee cart/truck. By confirming your reservation and making the required deposit payment, you acknowledge and accept these terms and conditions in their entirety.

RESERVATION AND PAYMENT:

- 1.1. To secure your reservation, a non-refundable deposit of 25% of the total quote is due at the time of confirmation.
- 1.2. The remaining balance must be paid on the day of the rental.

CANCELLATION AND REFUNDS:

- 2.1. In the event of cancellation, a cancellation fee of 10% of the total rental fee will be charged.
- 2.2. Cancellations made within 48 hours of the scheduled rental start time will result in a 25% cancellation fee.
- 2.3. To cancel a reservation, you must provide written notice via email or other written communication.

RENTAL PERIOD:

- 3.1. The rental period begins at least 1 hour before the agreed-upon start time to account for set-up and ends at the agreed-upon end time.
- 3.2. Any extension to the rental period must be requested in advance and is subject to availability. Additional charges may apply for extended hours.

RESPONSIBILITIES AND USE OF THE COFFEE CART/TRUCK:

- 4.1. The rented coffee cart/truck is to be used solely for the purposes of providing coffee-related services and associated products.
- 4.2. You are responsible for obtaining any necessary permits or licenses required to operate the coffee truck at your desired location(s).
- 4.3. The coffee truck shall be operated in compliance with all applicable laws, regulations, and health and safety standards.
- 4.4. The customer shall confirm access to a restroom and/or sink for use by the company.

POWER REQUIREMENTS:

- 5.1. The coffee cart requires (1) 120V (15/20-amp) outlet. The coffee truck requires level ground and access to power during the rental period. The coffee truck requires either four separate 15/20-amp outlets or two separate 30-amp outlets.
- 5.2. You are responsible for providing suitable power sources at the rental location.

GOVERNING LAW AND JURISDICTION:

- 6.1. These terms and conditions shall be governed by and construed in accordance with the laws of the jurisdiction in which the rental takes place.
- 6.2. Any disputes arising from these terms and conditions shall be subject to the exclusive jurisdiction of the courts in the aforementioned jurisdiction.

ENTIRE AGREEMENT:

- 7.1. These terms and conditions constitute the entire agreement between you and us regarding the rental of the coffee truck, superseding any prior agreements or understandings, whether written or oral.
